**SUBMISSION OF VIDEO RECORDINGS OF IVATAN/ITBAYAT INDIGENOUS
KNOWLEDGE SYSTEMS AND PRACTICES (IKSPS)**

1. In line with the celebration of Indigenous Peoples Month this October, all schools are required to submit raw video recordings of **teachers demonstrating** or **learners participating** in various Ivatan Indigenous Knowledge Systems and Practices (IKSPs). These videos will be utilized in creating an audio-visual presentation that will not only highlight the rich cultural heritage of the Ivatan people but also demonstrate how these traditions are being actively passed on to the younger generation through the schools.
2. Recorded videos may feature activities from the current school year or previous ones. The Indigenous Knowledge Systems and Practices (IKSPs) showcased may include, but are not limited to, the following:
 - a. Fishing (e.g., traditional fishing techniques)
 - b. Planting (e.g., sustainable agricultural practices)
 - c. Weaving (e.g., basket-making, hat-weaving)
 - d. Cuisine (e.g., preparation of Ivatan traditional food)
 - e. Traditional medicine (e.g., herbal medicine and healing practices)
 - f. Other Ivatan practices relevant to the community. (Refer to Division Memorandum No. 208, s.2023 – Project **KASULIVAN** for other possible activities)
3. The raw videos must be clear and should emphasize authentic practices. The schools must obtain proper consent from individuals featured in the videos, particularly learners.
4. The deadline for submission is October 7, 2024, via this link: <https://forms.office.com/r/b3bSyS6Zqu>. Each school can upload up to ten (10) videos with a maximum of 100 MB per video.

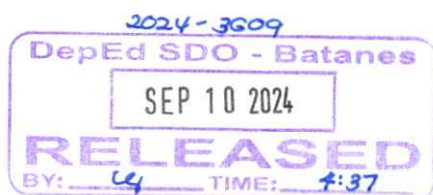
