2. This office approves their request to allow students to participate in this event. Participants are children aging from 10-18 years old and it goes as follows:

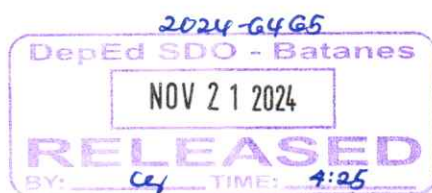

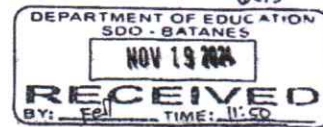
