- 3 The functions of Division ETF members include, but are not limited, to the following
- a. Maintajn an Operation and Monitoring Center to document and report all teachers and school-related issues and concerns before, during and after the Elections.
- b. Ensure that teachers are provided with and/or adequate information, technical and legal assistance during the performance of their duties as members of the Electoral Board.
- c. Serve as DepEd institutional link to volunteer organizations and individuals.
- d. Provide close horizontal and vertical coordination and consultation among DepEd, COMELEC and partner agencies involved in the 2025 National & Local Elections.
- e. Complement the other government agencies' efforts for an honest, orderly, and peaceful election.
- 4 The Division ETF will ensure that teachers shall be provided with adequate information, and technical and legal assistance during the performance of their duties as members of the Election Board, as well as DepEd non-teaching personnel who will serve during May 12, 2025, National and Local Elections.
- 5 The Division Election Task Force (DETF) Operation and Monitoring Center shall be established at the Schools Division Office, Kaychanarianan Basco, Batanes starting at 8:00 A.M. on May 11, 2025, and ending at 5:00 P.M. on May 13, 2025, Tuesday.
- 6 The Operation and Monitoring Center shall serve as DepEd institutional link to volunteer organizations, individuals, as well as partner agencies involved in the conduct of the 2025 Local and National Elections.
- 7. All DepEd Division, district, and school personnel, being in the civil service, are reminded not to intervene directly or indirectly in any election campaign or engage in any partisan political activity, except to vote.
- 8. All ETF members shall be entitled to honoraria or service credit subject to the availability of funds and in compliance with applicable issuances of the Commission on Audit and the Department of Budget and Management.
- 9. For guidance and strict compliance.
