1. In line with DepEd Order No. 32, s. 2015 entitled "Adopting the Indigenous Peoples Education Curriculum Framework" which recognizes the importance of integrating indigenous cultural traditions into the basic education system, the Curriculum Implementation Division (CID) will conduct a Division Workshop on Ivatan Songs and Musical Instruments on August 29-31, 2025 at the Ivatan Conference Hall.

2. The objectives of this activity are as follows:

- a. To teach participants the basic techniques of playing rondalla instruments;
- b. To enable participants to learn and perform a selection of Ivatan songs arranged for rondalla;
- c. To foster a deeper appreciation of Ivatan music and culture among participants, encouraging them to share and promote Ivatan heritage within their school communities.

3. Participants in this Training Workshop are select Elementary and Secondary teachers. (see enclosure No. 1)

4. Teacher participants will be granted service credits for attending the workshop during weekends while non-teaching personnel who render service during the activity are entitled to Compensatory Time Off (CTO) in accordance with the Civil Service Commission (CSC) and Department of Budget and Management (DBM) Joint Circular No. 1, s. 2015 (sections 3.2 and 4.8).

5. Expenses for meals and training materials in relation to the conduct of this training shall be charged against the IPED Program Support Fund, while the travel expenses of participants shall be charged against their respective school's local funds, subject to the usual accounting and auditing rules and regulations.

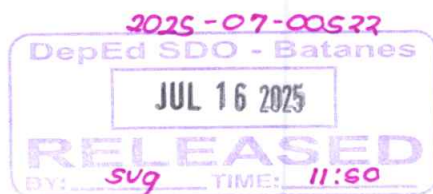
