5. Moreover, all learner participants shall secure parental consent duly signed by their parent or guardian. (*see enclosure 2 for parental consent*)



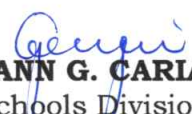

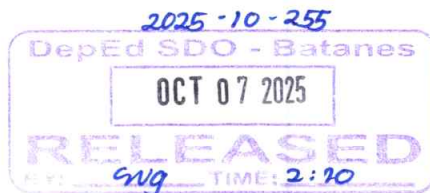
