**CONDUCT OF "BAYANIHAN SA PAGPAPATITULO NG MGA PAARALAN"
PROGRAM**

To: Assistant Schools Division Superintendent

1. In line with the Department of Education's mandate to secure land tenure of public school sites and to uphold and strengthen property rights, the Schools Division Office (SDO) of Batanes, through the Sites Titling Office (STO) under the Legal and Legislative Affairs strand of the DepEd Central Office, in partnership with **Atty. Blake S. Feken** and his team from **RealtyPro & Diligence, Inc.**, will implement the **Bayanihan sa Pagpapatitulo ng mga Paaralan** Program on **October 22-24, 2025**. The **venue** will be issued through a separate advisory **one (1) week prior** to the activity.
2. This initiative underscores the STO's dedication to institutional reform, inter-agency collaboration, and investment in securing tenure as a critical support to teaching and learning. Specifically, the program aims to:
 - a. Enhance monitoring systems and field coordination protocols;
 - b. Strengthen due diligence processes for land ownership verification;
 - c. Standardize titling documentation practices and compliance requirements; and;
 - d. Sustain inter-agency cooperation to expedite the titling of school properties.
3. The **List of Participants** and **Program Management Team** are contained in **Enclosure 1**. All identified participants are directed to attend punctually and to bring pertinent documents relevant to their school sites, as advised by the STO/Program Team.
4. Transportation expenses of participants both SDO and CO relative to this activity shall be charged against school MOOE or any available local funds and CO fund respectively. Moreover, accommodation of CO participants including meals and snacks of other participants and the venue for the said activity shall be charged against the downloaded SDO funds subject to the usual accounting and auditing rules and regulation.

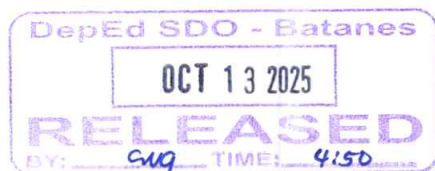
