- **Eligibility:**

Republic Act (RA) No. 1080, as amended (Teacher)

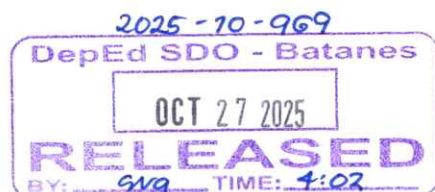
