

**Enclosure 1. PISA DAY DETAILS OF IMPLEMENTATION**

**1. Schedule:**

- a. PISA Day will be held every second and third Friday of each month, starting from the third week of October 2024 until the third Friday of February 2025.
- b. Specific dates and number of hours:

<b>Dates</b>	<b>Number of Hours</b>
October 18, 2024	1
November 08 and 15, 2024	2
December 13 and 20, 2024	2
January 10 and 17, 2025	2
February 17 and 21, 2025	2

**2. Duration:**

- a. Each **PISA Day session** will last for **1 hour**, during which participants will undergo computer-aided assessment.

**3. Scope:**

- a. Only identified qualified PISA participants will be involved in this activity.
4. The sessions will cover the following domains:

- a. **Language:** Comprehension, fluency, and critical analysis.
- b. **Mathematics:** Problem-solving, numerical reasoning, and real-world application.
- c. **Science:** Inquiry-based learning, scientific reasoning, and engagement with the natural world.

**5. Roles and Responsibilities:**

- a. **Education Program Supervisors (EPS):** Monitor and oversee the conduct of PISA Day activities in assigned schools.
- b. **School Heads:** Ensure that the sessions are conducted as scheduled and aligned with PISA standards.
- c. **Teachers:** Administer assessments, provide feedback, and track students' progress.

**6. Monitoring and Evaluation:**

- a. The Division Monitoring and Evaluation Team will periodically visit schools to ensure smooth implementation.
- b. A post-assessment report must be submitted by school heads by February 2025.
