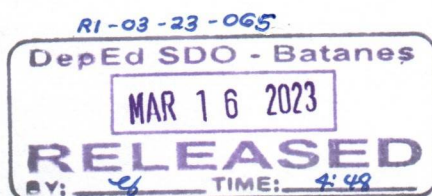
**ADDITIONAL REGISTRY OF ACCREDITED SUPPLIERS IN THE SCHOOLS


