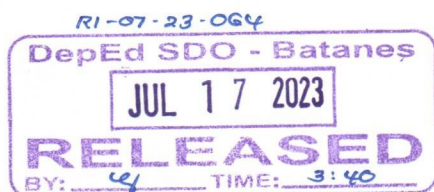
**ADDITIONAL REGISTRY OF ACCREDITED SUPPLIERS IN THE SCHOOLS

**RESOLUTION ESTABLISHING ADDITIONAL REGISTRY OF QUALIFIED SUPPLIERS IN
THE SCHOOLS DIVISION OF BATANES**

WHEREAS, the procurement initiatives for all locally funded projects and centrally managed funds by the Department of Education (DepEd), Schools Division of Batanes is governed by Republic Act No. 9184, also known as the Government Procurement Reform Act, and its Implementing Rules and Regulations;

WHEREAS, in accordance with relevant provisions, the DepEd – SDO Batanes shall established a Registry of Accredited contractors, managed by the Bids and Awards Committee, which is a master list of all bonafide suppliers with complete documentary requirements. Eligibility requirements required for a specific project especially competitive bidding such as updated legal, financial, and technical documents required in procurement transactions in the Philippine government shall be required as a separate requirement for every bidding opportunity;

WHEREAS, all bonafide suppliers who wish to do procurement business for goods and services, infrastructure, and consultancy services with the DepEd - SDO Batanes must be accredited and duly listed in the said Registry;

WHEREAS, the Procurement Service through the Bids and Awards Committee of DepEd – SDO Batanes shall managed the accreditation of all interested contractors for every Calendar Year. All new application and renewal of application shall be assessed by the Committee and endorsed to the Head of the Procuring Entity for Approval;

WHEREAS, the approved application shall be issued a Certificate of Accreditation and shall be included in the Registry of Qualified Suppliers in the Schools Division of Batanes. The said Registry of Accredited Suppliers shall be issued through a Division Memorandum on the first quarter of every calendar year and shall be updated in the ensuing quarters if necessary;

WHEREAS, call for interested contractors and assessment of the same for the current calendar year has been conducted by DepEd – SDO Batanes. Copy of the Additional Registry of Qualified suppliers is attached;

NOW THEREFORE, we, the members of the Bids and Awards Committee (BAC) hereby RESOLVE as it is hereby RESOLVED;

- a) To recommend the approval of the list of accredited suppliers which will comprise the CY 2023 Registry of Qualified Suppliers in the Schools Division of Batanes;
