**CONDUCT OF SPED ADVOCACY ACTIVITIES**

1. Pursuant to the provision stated in DepEd Order No.023, s.2022 titled, *Child Find Policy for Learners with Disabilities Towards Inclusive Education* under Child Find Activities states the need to conduct a Disability Advocacy Campaign to raise awareness highlighting attitudinal change as an important factor in changing the lives of children with disabilities.
2. In line with this, all schools catering to learners with disabilities, and with SPED Centers shall implement activities on disability awareness (ie. Symposium, distribution of IEC materials, etc.) and encourage partner LGUs and organizations to implement their own activities about the importance of referring children with disabilities for proper intervention and provision of educational program and services.
3. The said activities shall be done preferably simultaneously on August 31,2023.
4. In view of the conduct of SPED Advocacy campaign, schools are directed to submit an accomplishment report of the activity which will be submitted to EPS Bernadette L. Vinalay on or before September 5,2023.
5. Widest dissemination of this memorandum and compliance to the same is desired.


